Installation

Extract the AppendPdfServer.zip to your hard drive.

Open the folder AppendPdfServer and go to Examples folder.

Run the test example.bat to test it's working.

Getting Start

In DOS go to the installation folder and type command: AppendPdfSrv.exe

AppendPdfSrv in1.pdf in2.pdf output.pdf

will append in2.pdf onto in1.pdf and create output.pdf

AppendPdfSrv in1.pdf in2.pdf

will append in2.pdf onto in1.pdf

For optimization of the destination document's structure

to reduce its size add /s parameter

Registration:

AppendPdfSrv /u username /k registration key

Notes:

If the name of file contains space character itself,

it must be enclosed in quotes
