What This Privacy Policy Covers

This policy covers how EducatorsHandbook.com, LLC treats personal information that EducatorsHandbook.com, LLC collects and receives, including information related to your past use of EducatorsHandbook.com, LLC products and services. Personal information is information about you, your school, or students at your school that is personally identifiable like your name, address, email address, or phone number, and that is not otherwise publicly available.

This policy does not apply to the practices of companies that EducatorsHandbook.com, LLC does not own or control, or to people that EducatorsHandbook.com, LLC does not employ or manage.

Information Collection and Use

EducatorsHandbook.com, LLC may combine information about you that we have with information we obtain from business partners or other companies.

EducatorsHandbook.com, LLC collects information about your transactions with us, including information about your use of the products and services that we offer.

EducatorsHandbook.com, LLC automatically receives and records information on our server logs from your browser, including your IP address, EducatorsHandbook.com, LLC cookie information, and the page you request.

EducatorsHandbook.com, LLC uses information for the following general purposes: to customize the advertising and content you see, fulfill your requests for products and services, improve our services, contact you, conduct research, and provide anonymous reporting for internal and external clients.

Information Sharing and Disclosure

- (3) We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of EducatorsHandbook.com, LLC's terms of use, or as otherwise required by law.
- (4) We transfer information about you if EducatorsHandbook.com, LLC is acquired by or merged with another company. In this event, EducatorsHandbook.com, LLC will notify you before information about you is transferred and becomes subject to a different privacy policy.
