QUESTION: 4

A 300 person shipping company is breaking away from the parent group and is in the design phase for their messaging system. They have chosen EmailXtender for their single mail server environment and are in the process of ordering hardware for the rollout. Their average message size is rather large (approximately 200 KB) and they get approximately 35 messages a day. Many users are remote and they want to archive (but not eliminate) all the PST files as they go live.

How can this be accomplished?

- A. In EmailXtender Administrator, browse to a PST file and set the scheduling to run at a defined time until a defined time (or until complete). The PST file will be archived as resources are available.

QUESTION: 6

During a very important pre-sales meeting with a global investment bank, the compliance solution comes under heavy criticism. The members in the meeting room do not want to archive all 20,000 users' email because only 3500 users actually conduct business requiring compliance and "real time journaling." However they do want to

manage all users' email with shortcuts to reduce storage costs and to shorten backup and restore times. They have already begun the centralization process and are running Exchange 2000 in five different locations around the world. The proposal is to implement three EmailXtender servers to manage the traffic.

How can this be accomplished?

A. Identify and manually move all the compliance mailboxes to new Exchange storage groups. Turn on journaling for these users only. Use EmailXtract to manage all the mailboxes, realizing that remote users might experience latency when using shortcuts.

B. This is not possible. EmailXtender archives all incoming, outgoing, and internal mail. Microsoft Journaling cannot distinguish between one group of users and another. Use EmailXtract to manage all users' email as required.

C. Turn on journaling for all Exchange servers. Create rules to ensure that only certain departments' email traffic is pulled and processed. Create a new folder to store the content removed by EmailXtract, and set retention periods separately.
