Overview

The following documentation explains how to use the Last Bell program. If you have any difficulties please contact support@varibyte.com.

Installation

Install the program by double clicking on Last Bell.prc. Once installed on the handheld, run Last Bell to complete the handheld based installation.

Registration

Registering Last Bell allows you to schedule an unlimited number of classes for an unlimited number of days. The unregistered version only allows you to schedule one class for one day.

To obtain a registration code for Last Bell visit: <http://www.handango.com/purchase>. Enter in Product ID: 82685 and then click "Add to Shopping Cart".

Once you obtain the registration code, register Last Bell by using the "Options" menu, tap "Register", enter in your registration code exactly as given and then tap the "OK" button. Then tap the "OK" button on the notification dialog.



Beaming a Demo Version

To beam a demo version of Last Bell to another handheld: On the Main Screen using the "Options" menu tap "Beam Last Bell".

Then tap "Beam Last Bell Demo" then, tap "Beam PDATAdvUtilsLib" then, tap "Beam PDATPELib", and finally tap "Beam PDATDBXLibRT". This will beam the Last Bell application and the three libraries needed to run it.

(Note: Last Bell will NOT work without the three libraries.)

Help

To access help on the "Info" menu tap, "Help". The help section will provide help for each part of the program.


Main Screen

When Last Bell is first installed the main screen is blank.

To edit the schedule open the menu.
(To open the menu tap on the upper left corner of the screen.)

Make sure "Options" is selected, and then tap on "Edit Schedule".

To edit the schedule it is best to first enter in the days of the week, and then the classes you are taking.



Editing the Days of the Week

To edit the days of the week, from the **Last Bell Edit Schedule** screen, open the menu and tap on "Options" and then on "Edit Days".

You are now on the **Last Bell Edit Days** screen.

Next to the word "Day:" enter in the first day, for example Monday.

Then add the rest of the days by tapping the "New" button.

The "<" button moves to the previous day.

The ">" button moves to the next day.

To delete a day tap the "Delete" button.

Once all of the days have been entered tap the "Done" button to return to the **Last Bell Edit Schedule** screen.

Editing the Classes

To edit the classes, from the **Last Bell Edit Schedule** screen, open the menu and tap on "Options" and then on "Edit Classes".

You are now on the **Last Bell Edit Classes** screen.

Next to the word "Class:" enter one of your classes.


Then add the rest of the classes by tapping the "New" button.

The "<" button moves to the previous class.

The ">" button moves to the next class.

To delete a class tap the "Delete" button.

Once all of the classes have been entered tap the "Done" button to return to the **Last Bell Edit Schedule** screen.



Scheduling Classes


If you have a History class on Monday from 11:00 a.m. to 11:45 a.m. in room 505 this is how you would schedule it.

Next to the word "Day:" tap on the down arrow. A list of days you entered in **Editing the Days of the Week** will appear. In this example the class is on Monday so tap Monday.

Now next to the word "Class:" tap on the down arrow. A list of classes you entered in **Editing the Classes** will appear. In this example the class is History so tap History in the list.

Tap next to the word "Room:" and enter room 505.

Tap next to "Start:" which will bring up a dialog. Use this dialog to specify a start time of 11:00 a.m. and then tap the "OK" button.

Tap next to "End:" which will bring up a dialog. Use this dialog to specify an end time of 11:45 a.m. and then tap the "OK" button.

You have now successfully entered a class into the program.

To add more classes tap the "New" button.

The "<" button moves to previous classes.

The ">" button moves to the next class.

To duplicate a class, tap the "Dup" button. (Use this when you have a class at the same time on more than one day. Duplicate the class changing the day each time.)

To delete a class tap "Delete".

To finish editing classes tap the "Done" button.
You are now on the **Main Screen**.

Viewing the Schedule

To view the schedule for a different day of the week tap on the arrow or on the current day and then choose a day from the list.

This will show your schedule for that day. To edit a particular scheduled class you can tap on it in the schedule.

Each time you start the program it will automatically go to the current day of the week.




HW Diary

On the menu under "Options" there is a choice called "HW Diary". Tapping this will display a dialog with "Lib not found! Lib=HwDy". To download HW Diary so that this dialog does not display visit:
